Minnie Belle Leonard, active in area affairs for many years and a member of the pioneer Lieuallen family, died Sunday in Pullman. She was 92.

The youngest daughter of Hosiah and Joanne Lieuallen, she was born April 10, 1876, in Athena, OR. Her parents died when she was young, and she then made her home with her sister, Amanda MacArthur in Portland. Educated at Eastern Normal school and St. Helens Hall for Girls in Portland, she majored in music. She later studied art in California. She was married to Edgar Harvey Leonard Nov. 7, 1900 at Athena.

Mrs. Leonard was a member of the Presbyterian Church of Walla Walla and was active in the women's groups in the Prescott, Dayton and Waitsburg areas in her early life. She was also a member of the Daughters of the Nile, the Walla Walla Art Club and the Walla Walla County Republican Women. She was past worthy matron of the Order of the Eastern Star, a past chief and one of the founders of the Prescott chapter of the Pythian Sisters, and a active member of the P.E.O. for 40 years.

Funeral services for Mrs. Leonard will be Wednesday at 1:30 pm in the Walla Walla First Presbyterian Church with the Rev. Charles Messinger officiating. Interment will follow in Mr. View Cemetery.

Surviving her is a daughter, Mrs. Robert Emerson of Pullman, 4 grandchildren and 7 great-grandchildren.

Notes for EDGAR HARVEY LEONARD:

E.H. LEONARD

E.H. Leonard, who has long been known as a prominent representative of milling interests in the northwest, is now the vice president of the Preston-Shaffer Milling Company and active manager of its mill at Waitsburg. He was born in Walla Walla, May 16, 1873, and is a son of Thomas S. and Sarilda R. (Herren) Leonard. The father was a native of the state of New York, and the mother of Oregon having been one of the first white children born in that state. The date of the father's birth was April 25, 1840. He acquired a good education in the schools of that early period and in 1860 removed westward to Illinois, where for three years he engaged in teaching school, spending a part of the time also in Iowa. In 1863 he enlisted in the government service, being made a member of an organization for the purpose of rendering assistance and guidance to emigrant trains crossing the plains. On reaching the Boise river his train, feeling in comparative safety, disbanded and Mr. Leonard continued his journey to the coast, arriving in Portland, Oregon, late in November, 1863, when that now populous and progressive city was a town of but three thousand inhabitants. He afterward drifted to various points in the northwest and subsequently again took up educational work, teaching in the vicinity of Salem, Oregon, where he remained until about 1871. In the fall of that year he came to Walla Walla and in the spring of 1872 he removed to Dayton, where he has since resided. In the fall of that year he and his wife took charge of the Dayton school and in the spring of 1873 removed to a government land claim. In 1876 Mr. Leonard assisted in the organization of Columbia county and was elected the first county superintendent of schools. On the expiration of his term in that office he returned to the homestead and has since been engaged in farming. He has taken an active and important part in promoting the development of county and state along material and intellectual lines and has left the impress of his individuality for good upon the history of the community. In 1868 Mr. Leonard was united in marriage to Miss Sarilda R. Herren, a daughter of John and Docia (Robbins) Herren, who crossed the plains from Kentucky to Oregon in 1845. They settled near Salem, among the very early pioneers of that section. On her mother's side Mrs. Leonard comes of a family represented in the Revolutionary war, her great-grandfather, William Robbins, having been a participant in that struggle which led to the attainment of American independence. T.S. Leonard is one of the prominent citizens of Dayton and has for many years taken a prominent and helpful part in the development of Columbia county.

E.H. Leonard was reared to farm life and his education has been practically self acquired. He worked in his father's fields until his twenty-fifth year and in 1898 he became connected with milling operations as an employe of the North Pacific Flour Mills Company at Prescott. In March, 1900, he was made foreman of the mills and in July of the same year, when the mills were acquired by the Portland Flouring Mills Company. Mr. Leonard was made manager, which position he continued to fill until 1904. IN that year he was advanced to the position of district manager with the Portland Flouring Mills Company and in that connection had supervision over the mills of Dayton and Prescott and later also of Walla Walla. He continued in that capacity until January 1, 1916, at which time, having acquired an interest in the Preston-Shaffer Milling Company at Waitsburg, he was made assistant manager and removed to Waitsburg. This company also owns mills at Athena, Oregon. At the first meeting of the directors after his removal to Waitsburg, Mr. Leonard was elected to the vice presidency of the company in recognition of his marked ability and his long experience in the milling business. There is no phase of flour manufacture with which he is not familiar and in the operation of the plants of the Preston-Shaffer Company he utilizes the latest improved machinery and the most modern processes, displaying marked enterprise in the control of the

business. While thus extensively engaged in milling for nineteen years he has also continued his farming operations and now owns and operates two farms in Walla Walla county, comprising twenty-five hundred acres. he has thus become one of the prominent wheat growers of the Inland Empire. Either one of his business connections are sufficiently extensive and important to rank him with the representative business men of this section of the country. He is both forceful and resourceful and readily recognizes and utilizes opportunities which others pass heedlessly by. He is fortunate in that he possesses character and ability that awaken confidence in others and the simple weight of his character and his ability have carried him into important relations.

In November, 1900, occurred the marriage of Mr. Leonard and Miss Minnie Belle Lieuallen, of Portland, Oregon, and they have become the parents of three children: Mineta Belle, who is attending high school; Edgar Hugh, a student in the graded schools; and Joanna Jeanne.

Mr. Leonard is a republican in his political views and fraternally is connected with Waitsburg Lodge, No. 16, A.F.&A.M.; Dayton Chapter, No. 5, R.A.M.; and Walla Walla Commandery No. I, K.T. He also has membership with El Katif Temple, A.A.O.N.M.S., of Spokane, and belongs to Whetstone Lodge, No. 157, K. of P., of Prescott. His record is an inspiring one, for out of a struggle with small opportunities he has come into a field of broad and active influence and usefulness. Quick discernment and the faculty of separating the important features of any subject from its incidental or accidental circumstances have been strong phases in his career. His business has ever balanced up with the principles of truth and honor. He has ever been possessed of sufficient courage to venture where favoring opportunity is presented and his judgment and even-paced energy have carried him forward to the goal of success. His quietude of deportment, his frankness and cordiality of address, with the total absence of anything sinister or anything to conceal, foretold a man who is ready to meet any obligation of life with the confidence and courage that come of conscious personal ability, right conception of things and an habitual regard for what is best in the exercise of human activity.

The Star-Mirror, Moscow, Idaho, May 4, 1916: "Full of vigorous manhood, active in business pursuits and apparently in the very best of physical and mental health, John Wesley Lieuallen, one of the most prominent pioneer residents of Moscow, known throughout the state and in the entire Palouse country, passed away suddenly at his home on Third street yesterday afternoon after an illness of but a few moments duration, death being due to heart failure.

"The entire city is cast in gloom over the untimely death of this prominent public spirited citizen. The news of his death spread quickly and surprise and grief became evident everywhere. The heartfelt sympathy goes out to the wife and son in their anguishing moments.

"Mr. Lieuallen was about the city during the day attending to his various business engagements. In the afternoon he had gone to the Empire hardware store on a mission. He was attacked there and was quickly hurried to his home. Dr. Wilk was summoned at once by Mrs. Lieuallen and on his arrival observed his pulse was extremely low. Stimulants were administered to quicken the heart action which responded and for a moment there was hope, but he expired a moment later, conscious to the last. In his last moments he complained that he felt badly and apparently realized his serious condition. His son, Merritt Lieuallen, was summoned home from school, arriving just in time to see his father alive."

The Star-Mirror, Moscow, Idaho, May 8, 1916: "Citizens of Moscow and vicinity displayed in most striking manner the high esteem in which the late John Wesley Lieuallen was held in this community when there assembled at the funeral services at the family home on Third street one of the largest assemblages ever attending a similar function in the city, and despite the disagreeable windstorm that came abruptly to mar the beautiful day, a large concourse of friends followed the remains to their last resting place.

"Beautiful and impressive services were held both at the home and at the grave. The remains lay in the library of the home, beautiful floral gifts banked about the casket at every available space. A choir from the Methodist church sang sacred hymns and an impressive sermon was delivered by the Rev. D.H. Hare of the Presbyterian church. The services began promptly at 10 o'clock, but awaiting the arrival of Senator J.J. Day from Northport, one of the active pall bearers, the funeral party did not leave the home until 11 o'clock.

"The funeral was under the auspices of the Moscow lodge of Elks, of which order the deceased had been one of the most active and valued members. He had been No. 6 on the charter roll of Moscow lodge. Members of the Masonic bodies, of which the deceased was an active member, attended the funeral and each of the orders paid tribute with specially designed floral offerings.

"At the grave the impressive service of the Elks lodge was carried out by the Exalted Ruler Thorpe and officers of the lodge. "Thanatopsis," a special favorite of the deceased, was read by George D. Ayers. The choir sang "Nearer My God to Thee." The service closed with the casting upon the casket by members of the Elks lodge, a last floral offering.

"The memory of John W. Lieuallen will forever remain green among the people of Moscow. His loss to the community will not soon be forgotten. His work as a member of the improvement committee of the chamber of commerce and in other lines of a public nature has left the stamp of permanency indelibly impressed upon the community and the progress of city in a large part is due to his untiring and unselfish love for the things beautiful. The following is but a few expressions of business men of Moscow over the sudden death of John Wesley Lieuallen.

"The Moscow Chamber of Commerce passed the following resolutions in memory of the deceased: JOHN W. LIEUALLEN

"Whereas, It has pleased God in his infinite wisdom to take from us our honored citizen, John W. Lieuallen, be it

"Resolved, That in his death Moscow has lost one of her most distinguished and useful citizens. John W. Lieuallen came to Moscow more than thirty years ago. He was one of our earlier pioneers. During this long period of time, he has worked incessantly for the upbuilding and advancement of Moscow and Latah county. He has been a member of the chamber of commerce since its organization, and as an officer and member he has lent his time and ability to encourage the business advancement of the city and make it a better place in which to live. As chairman of the committee on public improvements, he guided the work of

the chamber of commerce in its efforts for the pavement of the streets, and the present attractive condition of our city is in large measure due to his untiring perservance and wonderful energy. Having retired from active business, for many years he has ungrudgingly given his time and means to the public interests. He was acquainted with everybody in Moscow. He was patriotic, loyal, and strong and constant in his friendships and his untimely death has left a place which cannot be filled. The chamber of commerce has learned with keen regret of his death, and the sincerest sympathy of the entire membership of the chamber of commerce and of the business men of this city goes out to his widow and son in this their great hour of bereavement. Be it further

"Resolved, That a copy of these resolutions be sent to his family, to the newspapers of the city, and that they be made a permanent record of the chamber of commerce."

James P. Lieuallen

A most prominent and progressive farmer of Umatilla county, residing on section 26, range 35, township 4, post office Weston, is James P. Lieuallen, who was born on this farm on the 12th of March, 1867, a son of William and Margaret (Fuson) Lieuallen. William Lieuallen was born in Anderson county, Tennessee, August 7, 1832, a son of Payton and Jemina (Smith) Lieuallen. When a small boy William Lieuallen left Tennessee with his parents, who settled near St. Joe, Missouri, but later removed to Mercer County, Missouri, where his father took up homestead on which he built a log house. The mother of William Lieuallen died here in 1859 and some time afterward the father went to make his home with a daughter, Mrs. Absalom Cox of DeKalb county, where he passed away. Throughout his life Payton Lieuallen had been a stanch supporter of the democratic party and firmly believed in the principles of that party as factors in good government. William Lieuallen assisted his father on the farm in Missouri until 1864, when he was married to Miss Margaret J. Fuson, and on April 15, the day after his marriage, he and his bride started for the west as members of an emigrant train. Many of their fellow travelers met their death on this journey, but Mr. and Mrs. Lieuallen came through unscathed. The journey was made by way of Omaha, up the Snake river, until they reached what is now knows as Weston. Here William Lieuallen took up a homestead of 160 acres of wild land, on which he built a log house, making his home here for some time. Her he took a prominent part in community affairs and served the public as justice of the peace for some time. He subsequently bought one-half section of railroad land up Pine creek for a stock ranch, and in 1899 he and his wife removed to Weston, where they bought a nice home. At the time of his demise, March 27, 1908, he was held in high esteem in the community, being readily recognized as one of Weston's representative

citizens. William Lieuallen also gave his allegiance to the democratic party and his fraternal affiliations were with the Masons. He had been a consistent member of the Baptist church throughout his life, for he had joined that church in 1859, having been reared in that faith since childhood. The wife of William Lieuallen was a native of Knox county, Kentucky, whose father died in that county, and late Mrs. Lieuallen sent for her mother to come to her home in Weston, and it was while residing with her daughter that Mrs. Fuson's death occurred. Three children were born to that union: Thomas A.; James P., whose name initiates this review; and John W. now deceased.

The boyhood of James P. Lieuallen was spent on the old home farm, on which he is now residing, and he received his education in the schools of Weston. Upon putting his textbooks aside he assisted his father with the farm work, continuing in this connection until his father's death, at which time he fell heir to one-half of his father's farm land, Thomas A. being the recipient of the other half. In agricultural circles Mr. Lieuallen is widely known as being most successful and progressive and he is in possession of 240 acres of farm land and has 315 acres in pasturage in addition to much range land. On his ranch he runs large numbers of cattle specializing in the Hereford breed.

In 1893 Mr. Lieuallen was united in marriage to Miss Eva G. Logan, a daughter of Miles and Mary Logan, and a native of McCune, Kansas. Mrs. Lieuallen came west with her mother, her father having died as a result of wounds received in the Civil War. Mr. Logan entered the service in 1862 and served two years, when he was honorably discharged, on account of ill health. To the union of Mr. and Mrs. Lieuallen ten children have been born: Roy, Lena, Mabel, James, Geneva, Lois, Thomas, Harlan, Herman, and Georgia.

Since age conferred upon Mr. Lieuallen the right of franchise he has been a staunch supporter of the democratic party, in the interests of which he has always taken an active part. He is fraternally affiliated with the Knights of Pythias, Knights of Khorassan, and the Woodmen of the Woods, and in connection with his stock raising interests he is a member, as well as president, of the Stock Association of Wenaha, and at Walla Walla. He is also president of the association in Weston, which he has served in that capacity since its organization 4 years ago.
